#### EIGIBILITY & FEES

All artists and/or craftsperson of the State of Hawaii are invited to enter. The non-refundable entry fee is \$10/entry, \$5/entry for Hawaii Craftsmen Members, no limit on the number of entries.

### CONDITIONS & DISPLAY REGULATION

No work shown previously in a juried exhibition on Oahu is eligible. All entries must be of original design and created independently within the last two years All exhibitors are required to sit the show for a minimum of three hours, find a substitute sitter, or pay \$15.

Size and weight: At the discretion of the exhibition chairperson an entrant, whose work poses an installation or handling problem, may be held responsible for the handling and installation of his/her pieces under the supervision and direction of the exhibit chairperson. If special display stands or installation devices are requested, an entrant may be required to provide his/her own.

\*All entries must be ready for display (books, rods, velcro, wire, etc. attached) with written instructions if hanging method is not obvious.

Liability: It is understood and agreed that all entries are submitted at the owner's risk. Care will be taken in the handling of all entries, but neither Fiber Hawaii '90 nor the AMFAC Plaza management will assume responsibility for the loss or damage to works submitted, no matter how such damage might be sustained.

Sales: A commission of 20% will be taken on all sales made at the exhibit. Pieces sold cannot be taken until the end of the exhibit, Wednesday, September 26, 9am-4pm. Accepted pieces must remain at the AMFAC Plaza for the total period of the exhibition and are subject to reproduction for publicity purposes.

Oahu: Deliver to AMFAC Plaza, Honolulu. Enter at makai end of Fort Street Mall, Tuesday, September 4, 9am-4pm.

Neighbor Islands: Mail entries to Hawaii Craftsmen, P.O. Box 22145 Honolulu, Hawaii 96822, to arrive between August 29 - September 1 ONLY or air freight with delivery direct to AMFAC Plaza, September 4, 9am-4pm ONLY. 
Accepted pieces MUST be picked up on Wednesday,
